El Paso, Texas— On Monday morning, around 9:48 A.M., police responded to a call of a man who was shooting a rifle outside of a neighborhood located in the 7800 block of Enchanted Ridge. The ongoing investigation has revealed Guerrero began to fire a handgun inside his residence next to the 42-year-old victim, causing her to flee from the home. Moments later, Guerrero went outside armed with a rifle and began to fire at multiple homes in the neighborhood. At that time, the 41-year-old victim was driving by the area when Guerrero started to fire at his vehicle. The 41-year-old victim was wounded and given first aid by a neighbor. He was later transported to a local hospital and was last listed in critical but stable condition. Afterward, Guerrero went to the home of Victims #3 and #4, where they were assaulted. Guerrero then disrobed and ran out of the residence as officers began to arrive. Guerrero then attempted to flee back into his residence when police apprehended him.
