The City of El Paso's Capital Improvement Department would like to invite you to a community meeting to learn more about the Sean Haggerty Drive Extension project.

These improvements will provide a vital and much needed roadway extension for Sean Haggerty Dr. between Nathan Bay Dr. to BU 54 (Dyer St.).

The project includes the construction of a new 4-lane bridge, roadway approaches, pedestrian/bicycle accommodations, aesthetic lighting, illumination, a canopy bridge structure and drainage structures.

The meeting will be conducted in an open house format. At the meeting, City staff will be on hand to answer any questions, listen to input, and take suggestions the public may have regarding the project. This project is part of the City of El Paso's commitment to enhance El Paso's regional comprehensive transportation system.

Written comments from the public regarding the proposed project are requested and may be provided at the meeting.
