### **COVID-19 Health & Financial Crisis Response**

- Strategic Plan is our guiding document
- Tools and resources implemented over the last several years to address the deferred investments and current pandemic
  - Fund balance buildup and budget stabilization creation
  - Strong management practices cost savings and efficiencies
  - Revenues created to fund priorities
  - Ability to be agile and proactive with budget adjustments





### **COVID-19 Health & Financial Crisis Response**

- Limited data and uncertainty surrounding impact
- Since early March we were proactive to address revenue impacts:
  - Implemented hiring freeze for non-essential positions
  - Closed multiple facilities (parks, museums, libraries)
  - Delayed opening of new amenities
  - Deferred non-essential capital projects
  - Organizational restructuring for efficiencies and savings





#### FY 2021 Adopted Budget Recap

- Protect residents and businesses by maintaining same tax rate
- Focused on the basics (police, fire, health, workforce)
- Unfunded all vacant non-essential positions
- Delayed opening of new amenities
- Deferred completion of capital projects (no debt issuance)
- Utilize CARES Act Federal funding
- Increased Budget Stabilization Fund





#### Budget Stabilization Fund – Established 3/3/2020

- Reserve to be used with the purpose of:
  - Minimizing future tax rate impact
  - Protecting against raising charges for services and fees
  - Providing available funding for specific circumstances or state of emergencies as determined by City Council

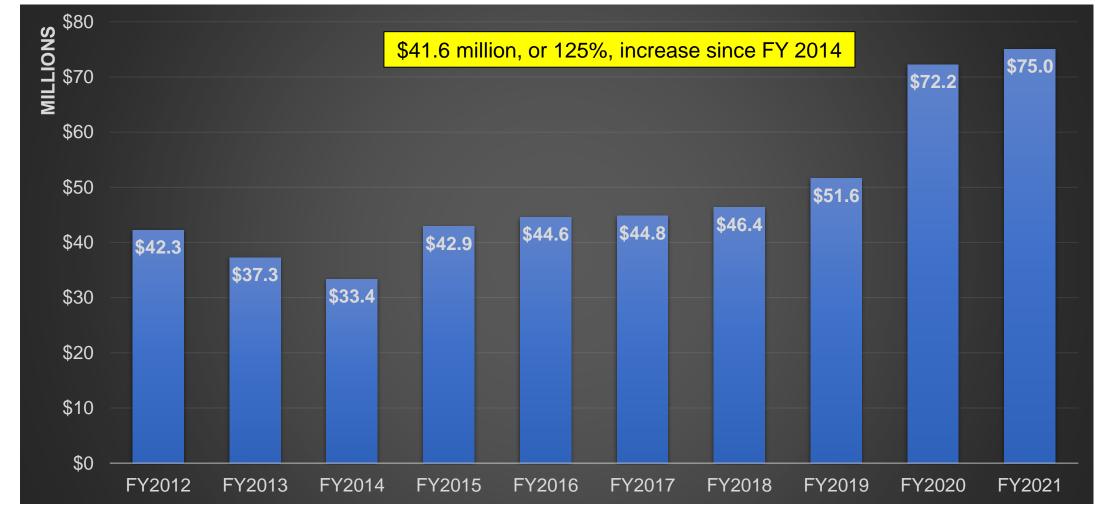
