- ❖ Portable restrooms are not provided; permanent restrooms are available at Reserves.
- ❖ No excavation or placing of stakes into the ground.
- ❖ Park Closed 10:00 p.m. – 6:00 a.m.
- ❖ No vehicles will be driven or allowed onto park grass areas.
- ❖ No restriction for the use of the areas or streets by the public shall be imposed.
- ❖ Littering and dumping of waste prohibited.
- ❖ Glass beverage containers prohibited.
- ❖ Alcoholic beverages are prohibited.
- ❖ Illegal to mark, damage, or destroy city property.
- ❖ Camping is prohibited.
- ❖ Use of any projectile is prohibited (firearms, air rifles, sling shots, driving golf balls, rock throwing).
- ❖ Remove pet droppings, use a leash.
- ❖ No horses.
- ❖ No amusement devices or jumping balloons without written permission.
- ❖ Permit required for sale of goods or services.
- ❖ Permit required for amplified public addressing.
