The City of El Paso’s Capital Improvement Department in conjunction with the Office of City Representative Isabel Salcido, District 5, have scheduled an open house community meeting to inform the public of the design of a BMX/Skate Park at Eastside Regional Park located near the intersection of Montana Avenue and Hueco Club Road,.

The design of the BMX/Skate Park is funded by the second phase of this 92-acre park project. Construction activities and funds will come at a later point in time, as funding becomes available for the construction of the BMX/Skate Park.

The first phase of Eastside Regional Park, which is already in construction, includes the construction of a competition ready indoor 50-meter pool, a new water park that includes a recreational pool, a splash pad, a lazy river, and a rock-climbing wall. The first phase also includes the construction of a new recreation center, a new parking lot for the park, the installation of landscaping, and the development of the associated streets for the project. Both phases are funded by the 2012 Quality of Life Bonds, which allocated \$48 million to the project.

When complete, Eastside Regional Park will be approximately twice as big as Eastwood (Album) Park, three times as big as Marty Robbins Park, and about four times as big as Yucca Park. Development of Eastside Regional Park is part of the City’s commitment to enhance El Paso’s quality of life through the creation of recreational, cultural and educational environments.
