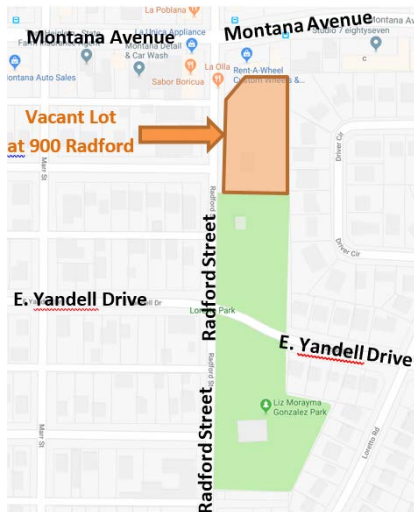

The City of El Paso’s Capital Improvement Department in conjunction with the Office of City Representative Alexsandra Annello, District 2, invites you to a community meeting for the Liz Morayma Gonzalez Park Expansion Project.

The meeting is designed to capture public input on the improvements, which will be made to the vacant lot located adjacent to Liz Morayma Gonzalez Park located at 900 Radford Road.



At the meeting City Staff will present an overview of three different improvement options for the public to consider. The improvements include walking paths, a futsal/roller derby dual purpose court, an exercise equipment area, a double bay swing set area, new landscaping, a parking lot and other amenities.
