Earth Day 2018 Trash Bin Art Contest Rules

- There is no fee to enter the contest.
- Art submissions must focus on recycling.
- All participants must be 18 years or older. Anyone under the age of 18 will be disqualified. **NO EXCEPTIONS.**
- Artwork and registration packets must be turned in together. You may submit your packet in PDF format via email (ESDEarthDay@elpasotexas.gov) or in-person (7968 San Paulo, El Paso, TX 79907). **Incomplete packets will not be considered.**
- Artwork will not be returned. Please do not send master copy.
- **Packets are due on Monday, February 26 by 5 p.m.** We will not accept any more packets after that time. 1st, 2nd, and 3rd place winners will be notified by Friday, March 2.
- Contest winners will be provided a trash bin, paint, supplies, and a sealant spray. Supplies will be dropped off on Tuesday, March 6 at the residence of the contest winner.
- Paint provided will be red, blue, yellow, black, white, and brown. Any additional colors needed will be at the expense of the contest winner.
- **Artwork must be completed solely by the artist(s).**
- Completed bins may be dropped off Monday – Friday between 8 a.m. and 5 p.m. at our Environmental Services Department building located at 7968 San Paulo Dr. The deadline to drop off your completed bin is **Thursday, April 5 by 5 p.m.**
- Bins will be placed on display at our ESD Earth Day Celebration on Saturday, April 7. Contest winners will be recognized at the event and receive trophies. If an organization/business is one of our contest winners, all participants will be recognized but only one trophy will be awarded bearing the name of the organization/business.
- Bins and artwork will not be returned. They will become property of the City of El Paso.
- Be aware that photos of contest winners and artwork may be shared on social media and our CityTV channel.

Trash Bin Dimensions Specification Sheet

- The **front face** of the trash bin is 24 inches wide at the top and 23 inches wide towards the bottom. The **side face** of the bin is 28 inches wide. The length of the entire bin is 42 inches long.



- Keep in mind that **the winner must paint ALL FOUR SIDES** of the container.
- **PLEASE LEAVE THE ID NUMBER AND CITY OF EL PASO SEAL ON THE BIN VISIBLE AND DO NOT COVER WITH PAINT.**
