**CAP Charges Man with Murder in Mulligans Shooting**

**EL PASO, Texas** – The El Paso Police Department's Crimes Against Persons (CAP) unit continues to investigate the Murder of Juan Martinez. Martinez died on 08/03/2017 as a result of the injuries he sustained after being shot on Sunday, 07/30/2017 at Mulligan's Chopped Hog Bar. Initially, 34-year old Javier GONZALEZ was arrested and charged in the assault. As a result of Martinez' death, GONZALEZ was rebooked at the County Jail today (08/11/2017) for the offense of Engaging in Organized Criminal Activity (E.I.O.C.A.) – Murder and his bond was set at \$1,000,000.00. On Thursday, 08/10/2017 the U.S. Marshal's Lone Star Fugitive Task Force arrested 58-year old Manuel GALLEGOS on an outstanding warrant for E.I.O.C.A – Assault that had been issued for his role in the 07/30/2017 shooting. GALLEGOS was booked into the El Paso County Detention Facility on \$70,000.00 bond late Thursday. This investigation continues.

**History 07-30-2017**

El Paso, TX. -Pebble Hills Regional Command officers responded to a shooting call at the Mulligan's Chopped Hog Bar at 1810 George Dieter. The Gang Unit was requested and are conducting the on-going investigation. The investigation revealed that one of the groups was told to leave the bar at which time there was an argument and a fight between the two gangs. While the fight was occurring an offender walked into the bar and began shooting at members of the rival gang. Four persons were shot leaving victims 1 and 2 with serious injuries and two others with injuries less severe. The offender fled the scene prior to arrival of the officers and no arrests have been made.
