## **Gang Unit Charges Five with Seven Guns**

**EL PASO, Texas** – The El Paso Police Department’s Gang unit has arrested and charged five Ruidoso, NM men with Unlawful Carrying of a Weapon after a Thursday evening traffic stop. The investigation revealed that five men were traveling together, 35-year old Zachary CARRIZAL operating a Harley-Davidson motorcycle, 55-year old Terry CLAUNCH operating a Harley-Davidson motorcycle, 35-year old Charles NEWBOLD was operating a Harley-Davidson motorcycle, 37-year old Scott STEVENS operating a Harley-Davidson motorcycle, and 24-year old Kaden HALL operating a Dodge truck failed to signal their intent in the 4500 block of Montana and again at Gateway North and Pershing. CARRIZAL, CLAUNCH, NEWBOLD, STEVENS, and HALL were stopped for the violation and all were found to be in possession of firearms. CARRIZAL (357 Magnum – Unlawful Carrying – Bond \$7,500.00), CLAUNCH (Para 45 cal. & 357 Magnum 2 counts Unlawful Carrying – Bond \$15,000.00), NEWBOLD (Taurus 40 – Unlawful Carrying – Bond \$7,500.00), STEVENS (Rugar 45 – Unlawful Carrying – Bond \$7,500.00) and HALL (Bersa .380 & Springfield 9mm – 2 counts Unlawful Carrying – Bond \$15,000.00) were placed under arrest and booked into the El Paso County Detention Facility. CARRIZAL, CLAUNCH, NEWBOLD, STEVENS, and HALL are confirmed Bandidos.
