Gang Unit and TAG Participants Arrest Five in July Assault

Date & Time: Sunday, July 15, 2018 @ 3:40 P.M.
Location: 3019 Montana Ave. (5 Points Bistro)
Arrested 1: 45 – year old Charles Edward ANDERSON Jr., of El Paso, TX
Arrested 2: 43 – year old Jennifeer ANDERSON of El Paso, TX
Arrested 3: 37 – year old Willie MORALES of Socorro, TX
Arrested 4: 44 – year old Keith Eleazar LOERA of El Paso, TX
Arrested 5: 29 – year old Sharl Lynn PEASE of Socorro, TX

EL PASO, Texas – Law Enforcement personnel assigned to the Texas Anti Gang Center (EPPD Gang unit, FBI Safe Streets Gang Task Force, Texas DPS CID Gang, EPPD SWAT and FBI SWAT) have arrested and charged five individuals as a result of a July 15, 2018 assault at 5 Points Bistro. The investigation revealed that (Charles ANDERSON, Jennifer ANDERSON, Willie MORALES, Keith LOERA, and Sharl PEASE – Heathens Horde MC) were engaged in a verbal altercation with another Motorcycle Group, identified as Valley Boys MC at 3:40 p.m. The confrontation escalated to a physical assault where (51-year old Male, 48-year old Female, 58-year old Female, 55-year old Male, 58-year old Male, 33-year old Male, 53-year old Male, & 45-year old Female) the listed victims were assaulted. TAG/EPPD Gang Investigators secured warrants on the listed charges, for C. ANDERSON (Aggravated Assault w Deadly Weapon – 5 counts, Tampering with Physical Evidence-1 count, Injury to Disabled-1count), J. ANDERSON (2 counts Assault-Serious Bodily Injury (SBI), 1 count Agg Ass. Deadly Weapon), W. MORALES (2 counts Assault, 1 count Agg. Ass. SBI, 1 count Injury to Disabled, 1 count Unlawful Possession of Metal or Body Armour by Felon), K. LOERA (2 counts Agg. Ass. Deadly Weapon), & S. PEASE (1 count Agg. Ass. Deadly Weapon) as being the individuals involved. The TAG Center agencies listed executed the warrants at various locations on July 31, 2018. All five individuals were taken into custody and booked into the El Paso County Jail. This investigation continues.
