Central Officers Charge Two with Guns, Marijuana, LSD, Hashish, Oxycodone, Cocaine and Hydrocodone

Arrested 1: 21 – year old Mychael Keshawn STEVENS of El Paso, TX
Arrested 2: 24 –year old Earnest Lenard HAMPTON OF El Paso, TX

EL PASO, Texas – Officers assigned to the El Paso Police Department’s Central Regional Command have arrested two El Paso men on several narcotic charges and one of the men was charged with Unlawful Carrying Weapon of 2 handguns. The investigation revealed that Central officers saw 21-year old Mychael STEVENS and 24-year old Earnest HAMPTON in a 2017 Hyundai Sonata parked next to their marked police vehicle at the 7-11. The Officers smelled the odor of burnt marijuana coming from the Hyundai. The investigation revealed that STEVENS and HAMPTON were in possession of marijuana, tetrahydrocannabinol (THC), MDMA (19 tablets – 4.5 grams), lysergic acid diethylamide (LSD - three paper strips), THC Wax (35.5 grams), Hashish (6.5 grams), Cocaine (1.5 grams), Oxycodone (.5 grams), Hydrocodone (.4 grams), and Alprazolam (7.5 grams). STEVENS was charged with Unlawful Carrying of a 9mm handgun (loaded and round chambered), a 25 millimeter Derringer handgun (loaded and round chambered), three counts of Possession of Controlled Substance, four counts of Manufacture Delivery of Controlled substance, two outstanding Municipal Warrants and one count of Possession of Marijuana. His bonds totaled \$29,424.00. HAMPTON was charged with one count of Possession of Controlled Substance, four counts of Manufacture Delivery Controlled Substance, one count of Possession of Marijuana and one outstanding Municipal warrant and bonds totaling \$26,350.00.
