18. Section 3 also requires the PM to have completed a minimum of three projects in the past five years of similar scope, each with a minimum construction cost of \$9M. Can the City elaborate on what qualifies as a similar scope (e.g., roadway, drainage, site development)?

Any civil work will qualify for the experience. Especially, if the project demonstrates experience in site development.
