

Households who have experienced COVID-related hardship may be eligible for the following programs. Please see the back of this flyer for a checklist of required documents.

Emergency Housing Payment Assistance



Rent

You may be eligible for up to \$3,000.00 in rental assistance for up to three months.

Mortgage

You may be eligible for up to \$3,750.00 in mortgage assistance for up to three months.

El Paso Community Card

\$2,000.00 MasterCard for City Resident
\$1,000.00 MasterCard for County Resident

Eligible households may receive a Visa MasterCard that may be used for essential household items such as groceries and prescriptions.



COVID-19 RELIEF PROGRAMS



Emergency Housing Payment Assistance

Qualifications:

- Must Reside within City of El Paso or El Paso County
- Behind on rent payment
- Income is less than 80% of Area Median Income or 200% of the Federal Poverty Level
- Cannot pay rent due to economic hardship from COVID-19

Required Documents:

- Completed Project BRAVO Application and all required documents listed on page one (1) of the Project BRAVO Application.
- Proof of hardship due to COVID
- RENT: Copy of lease/agreement
- MORTGAGE: Copy of correspondence from lender showing past-due amounts and current mortgage statement
- Photo ID of Landlord or authorized landlord representative
- ATTACHMENT A: COVID-19 NEEDS ASSESSMENT
- RENT: ATTACHMENT B: LANDLORD APPLICATION
- MORTGAGE: ATTACHMENT C: MORTGAGE VERIFICATION FORM OR PROOF OF MORTGAGE



El Paso Community Card Program

Qualifications:

- Must Reside within City of El Paso or El Paso County
- Income is less than 80% of Area Median Income
- Proof of COVID-19 related hardship

Required Documents:

- Completed Project BRAVO Application and all required documents listed on page one (1) of the Project BRAVO Application.
- Valid driver's license; or Government-issued identification card; or U.S. or international passport/immigration card
- Current utility bill or cellphone bill with name and address or official government or lending institution correspondence, directly addressed to applicant with applicant's name and current address;
- Proof of current address (if identification does not reflect the current address).
- Proof of hardship due to COVID:
