### NOTICE OF AMENDMENT TO 2019-2020 ANNUAL ACTION PLAN OF 2015-2020 CONSOLIDATED PLAN FOR USE OF CDBG-CV and HOPWA-CV FUNDS COVID-19 COMMUNITY RESPONSE + RECOVERY

The Department of Housing and Urban Development (HUD) has allocated to the City of El Paso over \$3.7 million in Community Development Block Grant COVID-19 (CDBG-CV) funds and over \$91,000 in Housing Opportunities for Persons with AIDS COVID-19 (HOPWA-CV) funds to assist with response and recovery to the COVID-19 health crisis. These CARES Act funds will be used to provide housing assistance, community and supportive services, access to basic needs, and financial counseling for individuals and households that have been directly impacted by the ongoing pandemic.
