ANY OUTBREAK, EXOTIC EMERGING DISEASE, OR UNUSUAL GROUP EXPRESSION OF DISEASE THAT MAY BE OF PUBLIC HEALTH CONCERN MUST BE REPORTED IMMEDIATELY. THIS INCLUDES ANY CASE OF A SELECT AGENT.

TEXAS LAW - Several Texas Laws (Health & Safety Code, Chapters 81, 84, and 87) require specific information regarding notifiable conditions to be provided to local and state health departments (CEPDPH & TDSHS). Health care providers, hospitals, laboratories, schools, and others are to report patients who are suspected of having a notifiable condition (Chapter 97, Title 25, Texas Administrative Code). Failure to report is a Class B misdemeanor that carries a sentence of up to 180 days and a fine up to \$2000 under the Texas Health and Safety Code, §81.049.

HIPAA - The HIPAA Privacy Rule [45 C.F.R. Section 164.512(b)] allows reporting without authorization for public health purposes and where required by law.
