City Continues Fiscal Year 2026 Budget Meetings with the Community Residents Invited to Join the Conversation

EL PASO, Texas—The City of El Paso reminds the public that the next opportunity to learn about and weigh in on the proposed Fiscal Year (FY) 2026 Budget is **tomorrow, Wednesday, July 23 at 10:30 a.m. at the Nolan Richardson Recreation Center, 4435 Maxwell.**

The proposed FY 2026 Budget reflects the City's continued commitment to public safety, infrastructure improvements, tax relief for seniors and disabled homeowners, and competitive wages and benefits for employees; all while maintaining a structurally balanced budget with no increase to the property tax rate.
