El Paso, Texas - Special Traffic Investigations were called to the scene of a collision involving four vehicles on Loop 375 northbound at MM 35, the collision resulted in one fatality. Prior to the fatal collision there was an unrelated collision which caused traffic to slow down. It was during this slower traffic flow the 2019 Silver Nissan Sentra operated by Kinkade was traveling at a high rate of speed and collided into the rear end of the 2021 Black Mazda 3 operated by Alonso Mario Lopez which set off a chain reaction involving a 2024 Blue Toyota Camry and a 2018 White Chevrolet Silverado. Both occupants of the Mazda 3 were transported to the hospital however Alonso Mario Lopez succumbed to the injuries sustained in the collision. Joshua Amid Serrano who was a passenger in the Mazda 3 suffered serious injuries.

Warrants were obtained for Terry Randall Kinkade for Intoxication Manslaughter with a split bond of \$750,000 surety / \$50,000 PR bond and Intoxication Assault with a split bond of \$250,000 surety / \$50,000 PR Bond signed by Judge Priddy. Kinkade will be booked pending a medical release.

This is the 60th traffic fatality compared to 55 at the same time in 2022. Speed and alcohol are the primary contributing factors in this collision. The El Paso Police Department urges all drivers to exercise caution, obey speed limits, and refrain from driving under the influence to prevent further loss of lives on the roads.
