EL PASO, Texas— On March 13, 2025, the El Paso Police Department responded to a burglary at the Loudmouth Vapor Smoke Shop, located in the 10200 block of Montana. Preliminary investigations revealed that a group of individuals used a stolen Hyundai to crash into the building to steal items from inside.

The Hyundai was recovered at the scene; however, the suspects fled the scene in a stolen Kia. Investigation by Auto Theft Task Force, Northeast and Pebble Hills Tactical units, led to officers later locating the suspects, who, at that time, evaded arrest on foot. A short time later, all individuals were apprehended.

Three of the juveniles involved were charged and referred to the Juvenile Probation Department, while the other two juveniles were charged and released into the custody of their parents.

The El Paso Police Department continues to investigate the incident.
