El Paso, Texas – The Special Traffic Investigations unit responded to a vehicle collision involving multiple vehicles involving a fatality. Preliminary investigation revealed vehicle 2 and vehicle 3 (trailer) became disabled on Loop 375. A tow truck (Yellow Kenworthy) was requested to tow vehicle 2 and vehicle 3 off the roadway. For unknown reasons the driver of the Kenworthy was not able to stop as it approached the intersection of Loop 375 and N. Dessert where several vehicles were stopped for the red light. As a result several vehicles were struck.

The investigation is ongoing.....
