GENERAL CONTRACTOR REQUIREMENTS FOR:

- New Commercial & Tenant Improvements
- New Residential, Additions, Alterations

1. Contractor Registration Application (\$102.00 Annual Fee)
2. Certificate of Insurance (GL) (Minimum \$100,000.00) *
3. Blanket Building Construction Bond (\$25,000.00) or
4. Blanket Building Construction Bond (\$10,000.00) can be submitted for the following :
 - a. Irrigation installations, b. Site lighting & landscape installations, c. Temporary structure placement, d. Mobile placement permits, e. Temporary sign permits, f. Tents in excess of 200 square feet, g. Fences, h. Patch & paint permits, i. Pavement cuts or excavation in the public right of way. Building Official shall have the authority to require a bond in the amount of \$25,000.00 if the subject work exceeds \$10,000.00 in valuation.
