## **Three Charged in Saturday Morning Aggravated Assault**

Date and Time: Saturday, November 11, 2017 @ 6:35 a.m.  
Location: 5700 block of Alameda  
Arrested 1: 26-year old Michael Ray ACOSTA of El Paso, TX  
Arrested 2: 21-year old Rafael RODRIGUEZ of El Paso, TX  
Arrested 3: 17-year old Jerrica ARREDONDO of El Paso, TX  
Detained 4: 16-year old Male

**EL PASO, Texas** – Officers from the El Paso Police Department’s Central Regional Command Center responded to a large fight at 6:35 a.m., Saturday morning at a residence in the 5700 block of Alameda. Officers saw a large group of individuals attempting to flee the complex upon their arrival. Central officers located two victims (20-year old male & 24-year old female) with a male sustaining a stab wound and a female who had been assaulted. The investigation revealed that 26-year old Michael Ray ACOSTA, 21-year old Rafael RODRIGUEZ, worked together to assault the male, and 17-year old Jerrica ARREDONDO assaulted the female. All three were placed under arrest and booked into the El Paso County Jail. ACOSTA (Agg. Assault – Bond \$270,000.00), RODRIGUEZ (Agg. Assault & Assault – Bond \$50,750.00), and ARREDONDO (Agg. Assault, Assault, - bond \$27,943). A 16-year old male was detained and turned over to Juvenile Probation Department for Harassment of Public Servant, Fail to Identify, Criminal Mischief, and Possession of Marijuana. A 23-year old female and a 19-year old male were charged with Public Intoxication as a result of this incident. The male victim received treatment. This investigation continues.
